### 1. WEBSITE DIRECT (Fastest and preferred)

### 2. TEXT

Text **SPRING2024** to **73876** to receive a direct link to the rebate website, where you can submit your forms.

### 3. MAIL-IN

To submit a mail-in rebate, visit CattleFirstProducer.com to download and print the mail-in form. Submit completed form along with proof of purchase (invoice) via mail. Please note mail-in submissions take longer to process.

### 4. EDI

If purchasing from an electronic reporting (EDI) entity, all data will be aggregated and processed at the end of the program for payment. Please allow 45 days from the end of the promotion for processing.

Multiple web or mail submissions will be accepted, and multiple proofs of purchase can be used with each submission. One rebate will be calculated per submission. Bonus offers will be calculated for all invoices included on each submission, and will not be calculated across multiple submissions. Producers who submit any rebates via mail or web will not be eligible for rebates on EDI transactions.
